REGARDING SPECIAL SERVICE PROPOSAL- BY-LAW NO.03/21 FOR THE COLLECTION AND TRANSPORTATION OF WASTE AND RECYCLABLE MATERIAL FOR THE RM OF COLDWELL.

The Council of the Rural Municipality of Coldwell has scheduled a public hearing at the Lundar Arena (Upstairs) on the 9th of April, 2021 at 7:00 pm to present the following special service proposal: To provide a Special Service levy for the collection and transportation of garbage and recycling from Residential and commercial properties within the municipality. Estimated costs for 2021 is \$174,580 and a per parcel rate will be \$215-225 single family, \$430-450 for a duplex, ect. Full description of Special service proposal is on the attached Schedule A.

A written objection may be filed with the Chief Administrative Officer, at Box 90 Lundar, MB R0C 1Y0 prior to the commencement of the hearing, At the hearing, Council will hear any potential taxpayer who wishes to make presentation, ask questions or register an objection to the special service proposal. Due to COVID restrictions please register with office if planning on attending.

All objections, written or verbal, must be filed prior to the adjournment of the hearing and must include the name, address and property description of the person filing the objection and the grounds of their objection.
